

PUBLIC NOTICE

THE BROMLEY (WAITING AND LOADING RESTRICTION) ORDER 2003 (AMENDMENT NO. 139) ORDER 2014.

(BEECHWOOD ESTATE, GREEN STREET GREEN)

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley on 15th July 2014 made the above-mentioned Order under Sections 6 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, and of all other powers thereunto enabling, which will come into operation on 28th July 2014.

The effect of the Order would be to introduce waiting restrictions as specified in the Schedule to this notice.

A copy of the Order may be inspected during normal office hours on Mondays to Fridays at the Bromley Civic Centre, Stockwell Close, Bromley, Kent until the expiration of a period of 6 weeks from the date of making the Order.

ANY person wishing to question the validity of the Order or of any of their provisions on the grounds that it is not within the powers of the relevant enabling Act or that any requirement of any such enabling Act or of any relevant regulations made thereunder has not been complied with, may within 6 weeks from the date on which the Order was made, make application for the purpose to the High Court.

SCHEDULE:-

WAITING RESTRICTIONS

No Waiting At Any Time:-

BEECHWOOD AVENUE, Orpington, (a) both sides, from the south eastern kerbline of Shire Lane south eastwards for a distance of 10m; (b) the east side, from a point 7m south east of the common boundary of Nos. 1 & 3 southwards to the northern boundary of No. 5.

CLEAVE AVENUE, Orpington, (a) the odd numbered side, (i) from the north eastern kerbline of Ramus Wood Avenue eastwards for a distance of 3m; (ii) from a point 25m east of the common boundary of Nos. 1a & 1c south eastwards to a point 16m north of the northern boundary of No. 1; (iii) from the south western boundary of No. 11 south westwards to a point 10m south west of the western kerbline of Kent Close; (b) the even numbered side, from a point 3m north of the northern flank wall of No. 2 to a point 3m west of the western flank wall of No. 2; (c) the island site fronting Nos. 2 to 16, (i) from a point 3m north of a point opposite the party wall of Nos. 2 & 4 clockwise to a point 18m north east of a point opposite the party wall of Nos. 1 & 3; (ii) from a point 2m north east of a point opposite the party wall of Nos. 5 & 7 clockwise to a point 2m south of a point opposite the party wall of Nos. 14 & 16; (d) the island site fronting Nos. 18 to 24, from a point 8m south west of a point opposite the south western boundary of No. 11 clockwise to a point 2m north east of a point opposite the party wall of Nos. 9 & 11.

COCKSETT AVENUE, Orpington, the north west side, from the western kerbline of Ramus Wood Avenue south westwards to a point 9m north east of the north eastern boundary of No. 2.

KENT CLOSE, Orpington, both sides, from the south eastern kerbline of Cleave Avenue southwards to the party wall of Nos. 1 & 3.

RAMUS WOOD AVENUE, Orpington, (a) the odd numbered side, (i) from the north eastern kerbline of Beechwood Avenue north eastwards for a distance of 10m; (ii) from the southern boundary of No. 23 southwards to the northern kerbline of Cleave Avenue; (b) the even numbered side, (i) from the eastern kerbline of Beechwood Avenue north eastwards to the common boundary of Nos. 4 & 6; (ii) from a point 4m north east of a point opposite the common boundary of Nos. 7 & 9 eastwards to a point 8m north west of the common boundary of Nos. 14 & 16; (iii) from a point 5m south east of the party wall of Nos. 20 & 22 southwards to the north western kerbline of Cocksett Avenue.

SHIRE LANE, Orpington, the south east side, from a point 10m north east of the north eastern kerbline of Beechwood Avenue south westwards to a point 10m south west of the south western kerbline of Beechwood Avenue.

No Waiting between 7am and 8am and between 5pm and 6pm on Mondays to Fridays inclusive:-

CLEAVE AVENUE, Orpington, the odd numbered side, from a point 16m north of the northern boundary of No. 1 south westwards to the south western boundary of No. 11.
