NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley proposes to make the above-mentioned Orders under Sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers.

#### The effect of the Orders would be to:-

- (a) introduce waiting and loading restrictions as specified in the Schedule to this notice;
- (b) formalise an existing Ambulance bay as specified in the Schedule to this notice:
- (c) remove 7m of parking space on the south side of Belmont Road, Beckenham at its easternmost end, adjacent to No. 342 Croydon Road and replace with 'At Any Time' waiting restrictions;
- (d) extend the Clock House, Beckenham Controlled Parking Zone (Zone 3) to include Hayne Road (and adjacent side roads) between Beckenham Road and Blakeney Road as specified in the Schedule to this notice:
- (e) remove the motorcycle bay outside No. 43 Hayes Street, Hayes and replace with/extend the existing 'At Any Time' waiting and loading restrictions by 3m;
- (f) amend the hours of operation of all Loading bays within High Street, Orpington Restricted Parking Zone from 'At Any Time' to Mondays to Saturdays inclusive between 8.30am and 6.30pm for any vehicle – maximum waiting time 30minutes with no return within 1 hour;
- (g) amend the hours of operation of the Loading bays within Bromley North Village Restricted Parking Zone (East Street and High Street only) from 'At Any Time' to Mondays to Saturdays inclusive between 8.30am and 6.30pm and Sundays between 10am and 5pm for any vehicle – maximum waiting time 15minutes with no return within 2 hours.
- (h) amend the Orpington parking places Order to reflect current parking spaces on-street.

Details of prohibitions and exemptions for certain vehicles and persons are contained in the original Orders.

A copy of the proposed orders, of the plans of the schemes and of the Council's statement of reasons for proposing to make the Orders can be inspected during normal office hours on Mondays to Fridays at the Bromley Civic Centre, Stockwell Close, Bromley, Kent.

ANY person wishing to object to the proposed Orders should send a statement in writing of their objection and the grounds thereof to the Executive Director of Environment and Community Services, Civic Centre, Stockwell Close, Bromley, BR1 3UH, quoting reference ADE(TP)/RP/T100/608 not later than 27th August 2014.

Persons objecting to the proposed orders should be aware that under the provisions of the Local Government (Access to Information) Act 1985, any comments received in response to this Notice may be open to public inspection.
