NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley on 3rd February 2015 made the above-mentioned Orders under Sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, and of all other powers thereunto enabling, which will come into operation on16th February 2015. The effect of the Orders would be to:-

- (a) introduce/extend/amend waiting and loading restrictions as specified in the Schedule to this notice;
- (b) introduce School Keep Clear markings as specified in the Schedule to this notice;
- (c) revoke the weight restriction in Plaistow Lane, Bromley over the railway line at Sundridge Park railway station
- (d) introduce new disabled parking bays as specified in the Schedule to this notice;
- (e) remove the disabled parking bays as specified in the Schedule to this notice; (f) amend various Orders to reflect the current positions on-street as a result of parking spaces being removed and being replaced with waiting
- restrictions, due to resident vehicle crossovers being installed; (g) introduce a residents permit parking scheme as specified in the Schedule to this notice;
- (h) renumber the existing parking places in Schedule 1 of the Orpington parking places order.

A copy of the Orders may be inspected during normal office hours on Mondays to Fridays at the Bromley Civic Centre, Stockwell Close, Bromley, Kent until the expiration of a period of 6 weeks from the date of making the Orders. ANY person wishing to question the validity of the Orders or of any of their provisions on the grounds that it is not within the powers of the relevant enabling Act or that any requirement of any such enabling Act or of any relevant regulations made thereunder has not been complied with, may within 6 weeks from the

date on which the Orders were made, make application for the purpose to the High Court. SCHEDULE:-WAITING RESTRICTIONS

No Waiting At Any Time:-

FORGEFIELD, Biggin Hill, (a) the north side, from the western kerbline of Main Road westwards to a point 2m west of the eastern boundary of No. 1; (b) the south side, (i) from the western kerbline of Main Road westwards to a point 6m north of a point opposite the northern flank wall of No. 7; (ii) from a point 0.5m west of a point opposite the party wall of Nos. 1 & 2 eastwards to the northern flank wall of No. 7. HILLVIEW CRESCENT, Orpington, the sides surrounding the island site.

MAIN ROAD, Biggin Hill, the west side, from a point 9m north of the northern kerbline of Forgefield southwards to a point opposite the northern flank wall of No. 155a.

MAYFIELD AVENUE, Orpington, the west side, from the north eastern kerbline of Hillview Crescent (south western arm) north eastwards to the southern

kerbline of Hillview Crescent (north eastern arm). MEREWOOD CLOSE, Chislehurst, both sides, from the south eastern kerbline of Woodlands Road south eastwards for a distance of 10m.

SOUTHOVER, Bromley, (a) the north east side, from a point 1.5m north west of the party wall of Nos. 88 & 90 south eastwards to a point 3m north west of the western flank wall of No. 78; (b) the south west side, from the north western kerbline of Rangefield Road north westwards to a point 5.5m south east of

the common boundary of Nos. 43 & 45. No Waiting between 1pm and 2pm on Mondays to Fridays inclusive:GLENTRAMMON AVENUE, Green Street Green, the west side, from a point 14m north of the northern kerbline of Glentrammon Gardens southwards to a

point 17m south of the southern kerbline of Glentrammon Gardens. **WAITING RESTRICTIONS - REMOVALS** No Waiting between 8am and 6.30pm on Mondays to Saturdays inclusive:-

THE FAIRWAY, Bickley, the east side, from a point 10m north of the northern kerbline of Southborough Lane northwards for a distance of 29m. SCHOOL KEEP CLEAR MARKINGS

No stopping between 8am and 9.30am and 2.30pm and 4pm on Mondays to Fridays inclusive.

PARK AVENUE, Bromley, the south side - Parish Church of England Primary School

RESIDENT PERMIT PARKING

Permit holders only between 10am and 12noon on Mondays to Fridays inclusive. Zone BAR. Residents Permits £40 per annum per vehicle:-

BARNMEAD ROAD, Beckenham, (a) the north west to south east arm, both sides, from the eastern kerbline of Kent House Road south eastwards to a point 24m east of the eastern boundary of No. 26a; (b) the north to south arm, both sides, from the south western kerbline of the north west to south east arm southwards
