LONDON BOROUGH OF BROMLEY

The Bromley (Waiting and Loading Restriction) Order 2003 (Amendment No. ***) Order 2015. (Worlds End Lane, Green St Green)

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bromley proposes to make the above-mentioned Order under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and all other enabling powers.

The effect of the Order would be to introduce waiting restrictions as specified in the Schedule to this notice.

Details of prohibitions and exemptions for certain vehicles and persons are contained in the original Order of 2003.

A copy of the proposed order, of the plans of the scheme and of the Council's statement of reasons for proposing to make the Order can be inspected during normal office hours on Mondays to Fridays at the Bromley Civic Centre, Stockwell Close, Bromley, Kent.

ANY person wishing to object to the proposed Order should send a statement in writing of their objection and the grounds thereof to the Executive Director of Environment and Community Services, Civic Centre, Stockwell Close, Bromley, BR1 3UH, quoting reference ADE(TP)/RP/T100/619 not later than 15th July 2015.

Persons objecting to the proposed order should be aware that under the provisions of the Local Government (Access to Information) Act 1985, any comments received in response to this Notice may be open to public inspection.

WAITING RESTRICTIONS

No Waiting At Any Time:-

ASH ROAD, Orpington, both sides, from the south western kerbline of Worlds End Lane southwards for a distance of 10m.

BEECH ROAD, Orpington, both sides, from the southern kerbline of Worlds End Lane southwards for a distance of 10m.

ELM ROAD, Orpington, both sides, from the southern kerbline of Worlds End Lane southwards for a distance of 10m.

FARRANT CLOSE, Orpington, both sides, from the north eastern kerbline of Worlds End Lane north eastwards for a distance of 10m.

GLENTRAMMON AVENUE, Green Street Green, the west side, from a point 18m north of the northern kerbline of Glentrammon Gardens southwards to a point 17m south of the southern kerbline of Glentrammon Gardens.

GLENTRAMMON GARDENS, Green Street Green, both sides, from the western kerbline of Glentrammon Avenue westwards for a distance of 11.5m. GLENTRAMMON ROAD, Orpington, both sides, from the northern kerbline of Worlds End Lane northwards for a distance of 10m.

OAK ROAD, Orpington, both sides, from the southern kerbline of Worlds End Lane southwards for a distance of 10m.

WOODLANDS ROAD, Orpington, both sides, from the northern kerbline of Worlds End Lane northwards for a distance of 10m.

WORLDS END LANE, Orpington, (a) the north side, (i) from the common boundary of Nos. 70 & 72 south eastwards to the common boundary of Nos. 74 & 76; (ii) from a point 10m west of the western kerbline of Glentrammon Road eastwards to a point 10m east of the eastern kerbline of Glentrammon Road;

(iii) from a point 10m west of the western kerbline of Woodlands Road eastwards to a point 10m east of the eastern kerbline of Woodlands Road; (iv) from a point 10m west of the western kerbline of Julian Road eastwards to a point 10m east of the eastern kerbline of Julian Road; (b) the south side, (i) from the party wall of Nos. 105 & 107 south eastwards to a point 3m north west of the common boundary of Nos. 111 & 113; (ii) from a point 10m west of the western kerbline of Elm Road eastwards to a point 10m east of the eastern kerbline of Elm Road; (iii) from a point 10m west of the western kerbline of Oak Road eastwards to a point 10m east of the eastern kerbline of Oak Road; (iv) from a point 10m west of the western kerbline of Beech Road eastwards to a point 10m east of the eastern kerbline of Beech Road; (v) from a point 10m west of the western kerbline of Holly Road eastwards to a point 10m east of the eastern kerbline of Holly Road.
