TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC ORDER 2016

THE QUEENS BIRTHDAY/THE BIG LUNCH - SUNDAY 12TH JUNE 2016

NOTICE OF PROPOSALS

1. THE Council of the London Borough of Bromley HEREBY GIVE NOTICE that in order to enable the holding of street parties on the specified dates THEY PROPOSE to make an Order the effect of which will be to impose the following restrictions:-

The following roads will be closed to through traffic at the times the signs are displayed between 8am and Midnight on Sunday 12th June 2016:

Farnborough & Crofton

- Tubbenden Lane South - between its junctions with Farnborough Hill and Palmerston Road

2. THE prohibitions referred to in paragraph 1 above shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002.
3. THE Order will come into effect at 8.00am on Sunday 12th June 2016 and will end at Midnight on Sunday 12th June 2016.
4. NOTHING in this order shall prevent pedestrian access at any time to any premises situated on or adjacent to any road to which the order relates, or to any other premises which are assessable from such a road.
5. ACCESS to properties will be maintained as far as is practicable from either side of the closure as appropriate.
6. NOTHING in the Order shall apply to anything done with the permission or direction of a Police Officer in Uniform or any other emergency vehicles.

TEMPORARY PROHIBITION OF VEHICULAR TRAFFIC

NOTICE OF INTENTION

BARFIELD ROAD BICKLEY

1. THE Council of the London Borough of Bromley HEREBY GIVE NOTICE that in order to allow Network Rail to deliver track panels, machinery and equipment safely to the Network Rail compound at the eastern end of Goshill Road Bickley THEY INTEND to make an Order the effect of which will be to impose the following restrictions on vehicular traffic:-

WAITING VEHICLES

No person shall, until the works are completed, cause or permit any vehicle to wait in Barfield Road Bickley during the specified dates and times displayed in this Notice, or any other street or part of a street adjacent thereto as may become necessary.

Any vehicle waiting in contravention of any restriction on waiting imposed by this Order may be removed under the provisions of the Removal and Disposal of Vehicles Regulations 1986, or by the Council in accordance with the powers conferred upon it.

2. THE prohibitions referred to in Paragraph 1 above shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs prescribed by the Traffic Signs Regulations and General Directions 2002.
3. THE Order will come into effect on Monday 6th June 2016 with no specified finish date.
4. THE Order will have a maximum duration of 18 months, and it is expected that the actual works will take up to 15 nights to complete and will begin on or after the commencement date of the Order. The proposed dates of the works are as follows:-
